can you dispute apple pay Yes, you can dispute Apple Pay transactions at 1-(850)(213)(9159) by contacting your card issuer within 60 days of the charge at 1-(850)(213)(9159). Open Wallet app to view details, 1-(850)(213)(9159) then call bank with merchant info and reason like unauthorized or incorrect amount at 1-(850)(213)(9159). Provisional credit often applies during review.

## Dispute Process
